

The lottery terms and conditions for RENT the musical are as follows:

- By entering the lottery, entrants are considered to have accepted the terms and conditions and agreed to be bound by them. Discounted tickets priced at £10 will be offered at every performance of RENT the musical at the New Theatre, Peterborough and Queen's Theatre Barnstaple, subject to availability. These tickets can only be accessed by participating in the RENT the musical online theatre ticket lottery.
- RENT the musical ticket lottery ("Lottery") is open to residents of Great Britain aged 18 or over. Employees may not enter the Lottery.
- To take part in the Lottery visit. www.RENT-Themusical.co.uk/lottery and enter your name, email and preferred performance(s). Once you have submitted this information, you will be entered into a prize draw and will receive a chance to win discounted tickets for one of your selected performance dates. You may only enter a Lottery once, any other entries by the same individual will not be counted.
- The Lottery will open until Monday 17th June 2024 at 12pm.
- We will hold a draw on Tuesday 18th June 2024. A second draw may take place, subject to availability. This is subject to change dependent on performance schedules.
- Winners will be selected at random from all complete, correct and eligible entries received by the closing date for each Lottery. We will then email successful entrants with instructions on how to book your £10 tickets. Tickets must be purchased within 24 hours and only the person who entered the Lottery can make a ticket purchase and all under 16s in attendance must be accompanied by an adult.
- The prize is up to 4 discounted tickets for your selected performance of RENT the musical. New Theatre Peterborough, PE or Queen's Theatre Barnstaple EX311SY.

Please note that the prize is for discounted tickets only and you will need to pay the discounted ticket price in order to attend your selected performance. The prize does not include any travel, expenses or other incidental costs.

Additional seats may be purchased at full-price if available. However, there is no guarantee that additional seats will be available at any price and/or that additional seats will be adjacent to Lottery seats. Lottery tickets are for new purchases only and refunds will not be made on any tickets already purchased.

A valid ID will be required when collecting tickets. There is no cash alternative to the prize and unless the Promoter agrees otherwise in writing the prize is non-refundable and non-transferable.

If any winner is not able, for any reason, to accept or claim a prize, or does not receive the email notification in order to claim the prize within the required deadline, the winner will forfeit their prize and the Promoter reserves the right to award the prize to another entrant.
